Re-invitation to Bid for the Renovation of DILG-CAR Staff House (Cottage), Quarters and Garage Canopy

- The DILG-CAR, through the GAA 2015/2016 intends to apply the sum of ONE MILLION SIX HUNDRED FORTY TWO THOUSAND NINE HUNDRED THIRTY SIX PESOS ONLY (PHP 1,642,936.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Renovation of DILG-CAR Staff House, Quarters and Garage Canopy. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The DILG-CAR now invites bids for the Renovation of DILG-CAR Staff House, Quarters and Garage Canopy. Completion of the Works is required within 50 calendar days. Bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. Provided, however, that contractor under small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than fifty percent (50%) of the Allowable Range of Contract cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Interested bidders may obtain further information from DILG-CAR and inspect the Bidding Documents at the address given below starting November 19, 2016 at 8:00 am to 5:00 pm Monday to Friday until the opening of bids on December 12, 2016 at 2:00PM.
- A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of FIVE THOUSAND PESOS ONLY (Php 5,000.00).
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
- The DILG-CAR will hold a Pre-Bid Conference on November 28, 2016 at 2:00PM at the BAC room, DILG-CAR, Engineers Hill, Barangay Center, Baguio City, which shall be open only to all interested parties who have purchased the Bidding Documents.
- Bids must be delivered to the address below on or before December 12, 2016 at 2:00PM at the BAC room, DILG-CAR, Engineers Hill, Barangay Center, Baguio City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted
- The DILG-CAR reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
