- The DILG-CAR, through the GAA 2016 intends to apply the sum of SIX MILLION NINE HUNDRED SEVENTY THREE THOUSAND EIGHT HUNDRED SEVENTY PESOS ONLY (PHP 6,973,870.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Repair and Upgrading of DILG-Barangay Center (Multi-Purpose Building). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The DILG-CAR now invites bids for the Repair and Upgrading of DILG-Barangay Center (Multi-Purpose Building). Completion of the Works is required within 90 calendar days. Bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid.: Provided, however, that contractor under small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than fifty percent (50%) of the Allowable Range of Contract cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

6. The DILG-CAR will hold a Pre-Bid Conference on February 1, 2017 at 2:00PM at the BAC room, DILG-CAR, Engineers Hill, Barangay Center, Baguio City, which shall be open only to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered to the address below on or before February 13, 2017 at 2:00PM at the BAC room, DILG-CAR, Engineers Hill, Barangay Center, Baguio City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
